(1) On April 3, 2017, the reporting person elected to redeem 1,656 shares out of 3,313 shares of vested phantom stock into 1,656 shares of ARMOUR common stock. The reporting person also elected to redeem the remaining 1,657 shares of vested phantom stock, but immediately forfeited those shares to pay income taxes on the vesting grant. The 3,313 shares are part of, and relate to, phantom stock vesting over a five-year period, which was reported on a Form 4 filed by the reporting person on March 21, 2013.
