Estimated Unaudited Assets Under Management

The Company is disclosing to investors in the private investment funds that it manages that, as of November 1, 2015, the estimated unaudited amount of assets under management was approximately \$13.8 billion, which reflects a net increase of approximately \$0.03 billion since October 1, 2015. The Company's estimate of assets under management is inclusive of performance for the month ended October 31, 2015 and capital flows as of November 1, 2015.

The Company owns between 30% and 55% of the general partners or managing members of the real estate (a) business, the activist business and the long/short credit business (the single strategy hedge funds). We do not possess unilateral control over any of these general partners or managing members.

(b) Includes approximately \$58.5 million of committed but undrawn capital that will only be charged fees when invested.

(c) These amounts include the Ramius Event Driven Equity Fund and the Company's invested capital of approximately \$163.8 million and \$163.4 million as of November 1, 2015, and October 1, 2015, respectively.

(d) These amounts include the Company's invested capital of approximately \$19.7 million and \$21.6 million as of November 1, 2015, and October 1, 2015, respectively.

(e) This amount reflects committed capital.

(f) Net performance is net of all management and incentive fees and includes the effect of any foreign exchange translation adjustments and leverage in certain funds.
