As calculated in accordance with Rule 13d-3 of the Securities Exchange Act of 1934, as amended, (i) Sabby Healthcare Master Fund, Ltd. and Sabby Volatility Master Fund, Ltd. beneficially own 154,900 and 41,200 shares of the Issuer's common shares (common shares), respectively, representing approximately 1.60% and 0.42% of the Common Stock, respectively, and (ii) Sabby Management, LLC and Hal Mintz each beneficially own 196,100 shares of the common shares, representing approximately 2.02% of the common shares. Sabby Management, LLC, a Delaware limited liability company, indirectly owns 196,100 common shares because it serves as the investment manager of Sabby Healthcare Master Fund, Ltd. and Sabby Volatility Warrant Master Fund, Ltd., Cayman Islands companies. Mr. Mintz indirectly owns 196,100 shares of common stock in his capacity as manager of Sabby Management, LLC.
