This Schedule 13G is being jointly filed by (i) Steamboat Capital Partners LLC ("IA"), (ii) Steamboat Capital Partners GP, LLC ("GP"), (iii) Parsa Kiai and (iv) Steamboat Capital Partners Master Fund, LP ("Master") with respect to shares of First Preferred Stock, Cumulative, par value \$25 per share, redeemable, 4.50% of the above named issuer owned by clients of IA including Master.

IA is the portfolio manager for Master and certain other entities. GP is the General Partner of Master and another fund managed by IA which owns shares of the class referred to herein. Parsa Kiai is the managing member of each of GP and IA.

The filing of this statement shall not be construed as an admission that any of the Reporting Persons is the beneficial owner of any securities covered by the statement other than the securities actually owned by such person (if any).
