- On April 3, 2006, Duke Energy Corporation, now known as Duke Power Company, LLC (Issuer), merged into a wholly-owned subsidiary of Duke Energy Holding Corp., now known as Duke Energy Corporation (Successor). In connection with the merger, each share of Issuer's common stock was converted into the right to receive one share of Successor's common stock.
- (1) Converts to Common Stock on a 1-for-1 basis.
  - (2) The phantom stock vests in 5 equal annual installments beginning on February 24, 2005.
  - (3) Expiration date not applicable.
  - (4) The phantom stock vests in 5 equal annual installments beginning on February 28, 2006.
  - (5) The phantom stock vests in 5 equal annual installments beginning on May 13, 2005.
  - (6) The phantom stock vests in 5 equal annual installments beginning on May 12, 2006.
  - (7) The option vests in 4 equal annual installments beginning on April 15, 2000.
  - (8) The option vests in 4 equal annual installments beginning on December 20, 2000.
  - (9) The option vests in 4 equal annual installments beginning on December 20, 2001.
  - (10) The option vests in five equal annual installments beginning on December 19, 2002.
