Arrow Financial Corporation (the "Company") held its 2016 Annual Meeting of Shareholders on May 4, 2016. As of the record date, March 7, 2016, there were 13,000,580 shares of the Company's common stock outstanding and entitled to vote. The holders of 10,251,090 shares of common stock, 78.85% of the outstanding shares entitled to vote as of the record date, were represented at the meeting in person or by proxy, and this amount represented a quorum. The proposals are described in detail in the Company's Proxy Statement filed with the Securities and Exchange Commission on March 25, 2016. At the 2016 Annual Meeting, our shareholders elected four Class C director nominees with terms expiring in 2019 to the Board of Directors and ratified the selection of the independent registered public accounting firm, KPMG LLP, as our independent auditor for the fiscal year ending December 31, 2016.

The matters acted upon at the Annual Meeting, and the voting tabulation for each matter, are as follows:

1: The election of four (4) directors to Class C for a term of three (3) years or until their successors shall have been elected and qualified.
