BHP Billiton Limited announces that on 20 November 2007 it purchased 1,350,000 ordinary shares of BHP Billiton Plc at an average price of 1,519,38 pence per ordinary share.

Following the above transaction, BHP Billiton Plc holds 24,165,516 of its ordinary shares as treasury shares and BHP Billiton Limited holds 28,622,510 of the ordinary shares in BHP Billiton Plc, forming a total of 52,788,026 shares. The total number of BHP Billiton Plc ordinary shares in issue (excluding shares held as treasury shares and shares held by BHP Billiton Limited) is 2,228,371,036.
