- Of the amount beneficially owned, 72,210 shares of common stock are issuable pursuant to awards of restricted stock units that vest in three installments, with 33.4% vesting on the first anniversary of the grant date and 33.3% vesting on each of the second and third anniversaries of the grant date. Of these 58,210 shares were granted on October 3, 2016 and 14,000 shares were granted on March 30, 2017. The remaining 10,049 shares of common stock are issued pursuant to an award of restricted stock units, granted on August 1, 2017, that vest in two installments, with 50% vesting on March 30, 2018 and 50% vesting on December 31, 2018.
