During the period covered by this report, the issuing entity guaranteed and the Bank issued (i) on September 11, 2014, U.S.\$1,500,000,000 2.125% Covered Bonds due September 11, 2019 and (ii) on September 17, 2014, EUR1,500,000,000 0.750% Covered Bonds due September 17, 2021.

The net proceeds from the sale of the Covered Bonds were added to the Bank’s general working capital and will be used for general working capital purposes.
