BLRA may be owner of the shares of Series B common stock of Celanese Corporation for the following reason: B common stock of Celanese Corporation are owned by Blackstone Capital Partners (Cayman) Ltd. 1 Capital Partners (Cayman) Ltd. 2 ("Cayman 2"), and Blackstone Capital Partners (Cayman) Ltd. 3 ("Cayman 1" and "Cayman 2", the "Cayman Entities"). Blackstone Capital Partners (Cayman) IV L.P. Cayman 1. Blackstone Family Investment Partnership (Cayman) IV-AA L.P. ("BFIP") and Blackstone Cap IV-AA L.P. ("BCP IV-A") collectively own 100% of Cayman 2. Blackstone Chemical Coinvest Partners collectively with BCP IV, BFIP and BCP IV-A, the "Blackstone Funds") owns 100% of Cayman 3. may be deemed to be the beneficial owner of the shares of Series B common stock held by the Blackstone Funds. Blackstone Management Associates (Cayman) IV L.P. ("BMA") is the general partner Blackstone Funds and may, therefore, be deemed to be the beneficial owner of the share of Series Cayman Entities. BLRA is the general partner of BMA and may, therefore, be deemed to be the Series B common stock held by the Cayman Entities.
