This Amendment No. 5 to Schedule 13G (this "Amendment No. 5") is being filed with respect to the common stock, par value \$0.01 per share (the "Common Stock"), of Third Point Reinsurance Ltd., an exempted company under the laws of Bermuda, to amend the Schedule 13G filed on February 14, 2014 (as amended by Amendment No. 1 thereto filed on February 13, 2015, Amendment No. 2 thereto filed on February 12, 2016, Amendment No. 3 thereto filed on February 10, 2017 and Amendment No. 4 thereto filed on February 9, 2018, the "Schedule 13G"). This Amendment No. 5 is being filed to report changes in the indirect ownership of the Reporting Person of shares of Common Stock. Capitalized terms used herein and not otherwise defined have the meanings ascribed to them in the Schedule 13G.

Item 4: Ownership:

(a) Amount beneficially owned:

8,881,451 shares. Of these shares, the 2010 Loeb Family Trust owns 300,000 shares of Common Stock, Third Point Advisors LLC owns 1,000,000 shares of Common Stock, Third Point Opportunities Master Fund L.P. owns 1,200,000 shares of Common Stock and the 2011 Loeb Family GST Trust owns 5,086,138 shares of Common Stock. Mr. Loeb has sole voting and dispositive power over the shares held by the 2010 Loeb Family Trust, Third Point Advisors LLC, the 2011 Loeb Family GST Trust and Third Point Opportunities Master Fund L.P. Mr. Loeb disclaims beneficial ownership of such shares of Common Stock except to the extent of his pecuniary interest therein, if any.
