- (1) Restricted stock units ("RSUs") convert into common stock on a one-for-one basis.
In connection with the vesting of shares of RSUs pursuant to the Frank's International N.V. 2013 Long-Term Incentive Plan, Frank's International N.V. (the "Issuer") withheld vested shares to satisfy tax withholding obligations. The number of vested shares withheld was based on the closing price per share on February 22, 2016. The withholding of vested shares pursuant to this award was approved by the Board of Supervisory Directors of the Issuer, and the number of shares indicated in this Form 4 was acquired as treasury stock by the Issuer.
- (3) On February 23, 2015, the reporting person was granted 60,096 RSUs, vesting ratably in three annual installments beginning on February 23, 2016.
- (4) Also consists of 68,182 RSUs that will vest 33% on August 14, 2016, with the remaining 67% vesting on March 31, 2017.

- (5) Each RSU represents a contingent right to receive, upon vesting, one share of common stock, par value Euro \$0.01 per share, of the Issuer.
- (6) The 37,037 RSUs reported on this Form 4 will vest ratably in three annual installments beginning on February 23, 2017.
