- (1) The reporting person previously elected to defer 455 shares of restricted stock vesting on June 7, 2016 (the shares of restricted stock were originally granted on June 7, 2013), and accordingly received 455 shares of phantom stock on June 7, 2016 pursuant to the PDC Energy, Inc. Amended and Restated Non-Employee Director Deferred Compensation Plan (the "Plan").
