The Schedule 13D filed on July 25, 2008 (the "Schedule 13D"), as amended by Amendment No. 1 filed on August 27, 2008, Amendment No. 2 filed on September 17, 2008, Amendment No. 3 filed on October 20, 2008, Amendment No. 4 filed on February 5, 2009, and Amendment No. 5 filed on May 6, 2009 by JANA Partners LLC, a Delaware limited liability company (the "Reporting Person"), relating to the shares ("Shares") of common stock, no par value, of Convergys Corporation, an Ohio corporation (the "Issuer"), is hereby amended as set forth below by this Amendment No. 6 to the Schedule 13D.

Item 3. Source and Amount of Funds or Other Consideration.

Item 3 of the Schedule 13D is hereby amended and restated as follows:

The 10,577,775 Shares (excluding 18,377 time-based restricted stock units) reported herein by the Reporting Person were acquired at an aggregate purchase price of approximately \$149.8 million. The Shares beneficially owned by the Reporting Person were acquired with investment funds in accounts under management.

Item 5. Interest in Securities of the Company.

Paragraphs (a), (b) and (c) of Item 5 of the Schedule 13D are hereby amended and restated as follows:

(a) The aggregate percentage of Shares reported to be beneficially owned by the Reporting Person is based upon 122,675,559 Shares outstanding, which is the total number of Shares outstanding as of March 31, 2009 as reported in the Issuer's Quarterly Report on Form 10-Q filed on May 5, 2009 for the period ended March 31, 2009.

As of the close of business on June 5, 2009, the Reporting Person may be deemed to beneficially own 10,577,775 Shares (excluding 18,377 time-based restricted stock units) constituting approximately 8.6% of the Shares

outstanding.

(b) The Reporting Person has sole voting and dispositive powers over the 10,577,775 Shares (excluding 18,377 time-based restricted stock units), which powers are exercised by the Principals.
