This information is being furnished pursuant to Item 12 of Form 8-K and is being presented under Item 9 as provided in the Commission's interim guidance regarding Form 8-K Item 11 and Item 12 filing requirements (Release No. 34-47583).

Additionally, as disclosed on the conference call held on April 24, 2003, because of recent legislation in Massachusetts which eliminated the state tax deduction of dividends Berkshire Bank received from its real estate investment trust subsidiary, the Company expects to incur an additional tax expense of \$0.02 per share per quarter for 2003. As a result, the Company updated its earnings guidance for the 2003 fiscal year announcing that it expects to meet and hopefully exceed net earnings of \$1.32 per diluted share for the 2003 fiscal year.
