Item 2.02. Results of Operation and Financial Condition

On July 22, 2010, Bancorp Rhode Island, Inc. (the "Company") issued a press release in which it disclosed unaudited financial information related to 2010 second quarter consolidated earnings. Following release, the Company discovered that, while the "Commercial loans and leases" and "Total loans and leases receivable" information on the Consolidated Balance Sheet (unaudited) included in the release were accurate, the amounts presented for "Subtotal," "Total Commercial Loans and Leases" and "Total Loans and Leases" in the June 30, 2010 column of the "Loan and Lease Portfolio" section of the Selected Financial Highlights (unaudited) were not correct and understated such amounts. The Company reissued the press release, correcting this error. A copy of the corrected press release, dated July 22, 2010, is attached hereto as Exhibit 99.1 and is incorporated herein by reference.
