On January 18, 2011, the Company granted 3,924 restricted shares as an annual grant to non-employee directors, valued at the then current market price of \$20.39 per share. Such shares vest on January 15, 2012 unless, with certain exceptions, the reporting person ceases to be a director prior to the vesting date.
- (3) Subject to the terms of the applicable award agreement, such options shall vest so long as the reporting person is still a director on such date.
- (4) Options expire on such date unless reporting person ceases to be a director, in which event options expire four years from the date reporting person's directorship ends.
