This Amendment No. 1 amends and supplements the Tender Offer Statement on Schedule TO (the "Schedule TO") filed by Eaton Vance Pennsylvania Municipal Bond Fund, a Massachusetts business trust (the "Fund") on October 22, 2015. The Schedule TO relates to the Fund's offer to purchase for cash up to 100% of its outstanding shares of preferred stock, par value \$0.01 per share and a liquidation preference of \$25,000 per share, designated Auction Preferred Shares, Series A (the "Preferred Stock"), upon the terms and subject to the conditions set forth in the Fund's Offer to Purchase dated October 22, 2015 (the "Offer to Purchase") and in the Fund's related Letter of Transmittal (the "Letter of Transmittal" which, together with the Offer to Purchase, as each may be amended and supplemented from time to time, the "Offer"), copies of which were previously filed as Exhibits (a)(1)(i) and (a)(1)(ii), respectively to the Schedule TO filed. The price to be paid for the Preferred Stock is an amount per share, net to the seller in cash, equal to 95.5% of the liquidation preference of \$25,000 per share (or \$23,875 per share), plus any unpaid dividends accrued through December 2, 2015. The information set forth in the Offer to Purchase and the related Letter of Transmittal, filed as exhibits to the Fund's Schedule TO, is incorporated herein by reference with respect to Items 1 through 9 and Item 11 of this Schedule TO.

Filed herewith as Exhibit (a)(5)(ii) and incorporated by reference is a copy of the press release issued by the Fund dated December 3, 2015, announcing the expiration of its tender offer and preliminary results.
