(1) On February 25, 2008, Reporting Person was granted 4,320 (target) performance-based restricted stock units ("PBRUs") pursuant to the Issuer's 2006 Long-Term Incentive Plan. On February 28, 2011, the Compensation Committee determined that the level of performance achieved entitled the holders of the PBRUs to 54% of their target award. Accordingly, on February 28, 2011, the PBRUs vested and converted into the number of shares set forth in this Form 4.

(2) Grant of Restricted Stock units pursuant to the 2006 Long-Term Incentive Plan.

(3) 50% vest on the third anniversary of the grant date and 50% vest on the fourth anniversary of the grant date.
