Capital Group International, Inc. CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 53,475,330 shares or 6.0% of the 894,558,000 shares of FON Group - Common Stock believed to be outstanding.
