**Item 1.01 Entry into a Material Definitive Agreement.**

On September 21, 2010, Medicis Pharmaceutical Corporation (the Company ) entered into a License and Settlement Agreement (the Settlement Agreement ) with Taro Pharmaceuticals U.S.A., Inc. and Taro Pharmaceuticals Industries Ltd. (collectively, Taro ). In connection with the Settlement Agreement, the Company and Taro agreed to terminate all legal disputes between them relating to the Company s VANOS® (fluocinonide) Cream 0.1%. In addition, Taro confirmed that certain of the Company s patents relating to VANOS® are valid and enforceable, and cover Taro s activities relating to its generic products under Abbreviated New Drug Application No. 20-0734. Further, subject to the terms and conditions contained in the Settlement Agreement, the Company granted Taro, effective December 15, 2013, or earlier upon the occurrence of certain events, a license to make and sell generic versions of the existing VANOS® products. Upon commercialization by Taro of generic versions of VANOS® products, Taro will pay the Company a royalty based on sales of such generic products.
