- Confirmation of all securities held by PNC Bank N.A., Bank of America, Chevy Chase Trust, M&T Investment Group, and Union Bank of California, in book entry form;
- Confirmation of all securities placed in escrow or out for transfer with authorized parties;
- Reconciliation of all such securities to the books and records of the Company and the Custodian; and
- Agreement of 17 security purchases and 24 security sales or maturities since our last report from the books and records of the Company to related agreements.

We believe that our examination provides a reasonable basis for our opinion. Our examination does not provide a legal determination of the Company's compliance with specified requirements.

In our opinion, management's assertion that Allied Capital Corporation complied with the requirements of subsections (b) and (c) of rule 17f-2 of the Investment Company Act of 1940 as of June 30, 2008, with respect to securities reflected in the investment account of the Company is fairly stated, in all material respects.
