- (1) Acquisition of 8,514 shares pursuant to Rule 16b-3 upon payout of 60% (15,480 units) of earned performance share award under shareholder-approved benefit plan. The payout was based on the level of achievement of financial targets for the performance period ended September 30, 2016. Of these 15,480 units, 8,514 units were paid in shares of Issuer stock, with the remaining 6,966 units paid in cash to cover the reporting person's tax obligations.
