#### Item 1. Security and Issuer

This Amendment No. 4 amends and supplements the Schedule 13D filed with the Securities and Exchange Commission on October 24, 2014, as amended by that certain Amendment No. 1 filed with Securities and Exchange Commission on January 14, 2015, that certain Amendment No. 2 filed with the Securities and Exchange Commission on August 17, 2016 and that certain Amendment No. 3 filed with the Securities and Exchange Commission on September 8, 2016 (collectively, this <u>"Schedule 13D</u>"), by (i) OCM Opps EB Holdings, Ltd., a Cayman Islands exempted company (ii) Oaktree Capital Management, L.P., a Delaware limited partnership (iii) Oaktree Holdings, Inc., a Delaware corporation (iv) Oaktree Capital Group, LLC, a Delaware limited liability company and (v) Oaktree Capital GP, LLC, a Delaware limited liability company (collectively, the <u>"Reporting Persons</u>"), with respect to the common stock, par value \$0.01 (the <u>"Common Stock</u>") of Eagle Bulk Shipping Inc., a Republic of the Marshall Islands corporation (the <u>"Issuer</u>"). The address of the principal executive office of the Issuer is 300 First Stamford Place 5th Floor Stamford, CT 06902.

The filing of any amendment to this Schedule 13D (including the filing of this Amendment No. 4) shall not be construed to be an admission by the Reporting Persons that a material change has occurred in the facts set forth in this Schedule 13D or that such amendment is required under Rule 13d-2 of the Securities Exchange Act of 1934, as amended.

As of December 15, 2016, as reflected in this Schedule 13D, the Reporting Persons beneficially owned that number of Common Shares (the <u>"Subject Shares</u>"), set forth on the cover pages hereto, which information is hereby incorporated by reference into this Item 1.

Item 3. Source and Amount of Funds or Other Consideration

Item 3 is amended and supplemented by adding thereto the following:

"On December 13, 2016, the Issuer, EB Holdings and certain other investors named therein entered into a Stock Purchase Agreement dated as of December 13, 2016 (the <u>"Stock Purchase Agreemen</u>t"), pursuant to which EB Holdings agreed to purchase from the Issuer an aggregate of 7,600,000 shares of Common Stock for an aggregate purchase price of \$34,200,000. Pursuant to the Stock Purchase Agreement, EB Holdings, together with the other investors, deposited the purchase price into escrow pending the satisfaction of customary closing conditions, including shareholder approval of such issuance. Following the satisfaction of such closing conditions, the Issuer will issue to EB Holdings 7,600,000 shares in connection with the Stock Purchase Agreement for an aggregate purchase price of \$34,200,000.

The foregoing description of the Stock Purchase Agreement does not purport to be a complete description of the terms thereof and is qualified in its entirety by reference to the full text of such agreement, which is referenced in Exhibit 1 to this Schedule 13D, and which is hereby incorporated by reference into this Item 3."
