- (1) RSU time-based grant 8/17/15, with 5-year vesting schedule, whereby shares to vest in equal increments over 5-years.
- (2) Shares used to cover taxes for vested shares
- (3) RSUs performance-based, granted 2/17/15 reported at maximum number of shares to vest. Actual number of shares to vest based on performance results
- (4) 2/15/17 RSU Time-Based Grant. Shares vest evenly over 3 years
