  - (2) the shares, if any, will be issued on or about March 2019 based on the issuer's performance for 2018 and the remaining one-half of the shares, if any, will be issued on or about March 2020 based on the issuer's performance for 2019. The Reporting Person will be entitled to sell the shares upon issuance provided the Reporting Person is continuously employed by the Company through the date of issuance.  
The option shall become exercisable with respect to the first 25 percent of the shares subject to the option when the Reporting Person
  - (3) completes 12 months of continuous service after November 13, 2017. The option shall become exercisable with respect to an additional 1/48th of the shares subject to the option when the Reporting Person completes each month of continuous service thereafter.
  - (4) The option shall become exercisable with respect to the shares subject to the option when the Reporting Person completes three years of continuous service after November 13, 2017.
