(1) Each restricted stock unit represents a contingent right to receive one share of Spansion Inc. Class A Common Stock. There is no exercise price or expiration date.

Restricted stock units were granted to the reporting person on December 15, 2005 and vest over a four-year period. One quarter of the shares subject to the award vested on April 28, 2006. The remaining shares subject to the award vest in equal installments quarterly, until 100% vested on April 28, 2009. Vested shares are delivered to the reporting person on each vesting date.
