**Item 8.01 Other Events.**

On January 24, 2005, Ampex Corporation announced that it has concluded license agreements with three manufacturers of digital still cameras based in Japan: PENTAX Corporation, Matsushita Electric Industrial Co., Ltd., and Victor Company of Japan, Ltd. The agreements were entered into pursuant to Ampex's ongoing patent licensing program, and permit the use of several U.S. and foreign patents held by Ampex in the manufacture and sale of digital still cameras.
