The undersigned registered closed-end investment company hereby notifies the Securities and Exchange Commission (the Commission) that it intends to call or redeem securities of which it is the issuer, as set forth below in accordance with the requirements of Rule 23c-2 under the Investment Company Act of 1940, and states that, pursuant to permission granted by the Commission staff, it is filing this notice with the Commission fewer than 30 days prior to the date set for the redemption.

1. Title of the class of securities of ClearBridge Energy MLP Opportunity Fund Inc. (the Fund) to be called or redeemed:
Series A Senior Secured Notes due February 7, 2020 (CUSIP # PPN 18469P A*1) (the Series A Notes).
Series B Senior Secured Notes due February 7, 2023 (CUSIP # PPN 18469P A@9) (the Series B Notes).
Series C Senior Secured Notes due February 7, 2025 (CUSIP # PPN 18469P A#7) (the Series C Notes) and together with the Series A Notes and the Series B Notes, the Notes).

2. The date on which the securities are to be called or redeemed:
The Notes will be prepaid on February 24, 2016.

3. The applicable provisions of the governing instrument pursuant to which the securities are to be called or redeemed:

The Notes are being prepaid pursuant to Section 8.2.2 of the Note Purchase Agreement, dated as of February 7, 2013.

4. The principal amount or number of shares to be called or redeemed and the basis upon which the securities to be called or redeemed are to be selected:

The Fund will prepay \$7,579,617.83 aggregate principal amount of its outstanding Series A Notes.

The Fund will prepay \$9,528,662.42 aggregate principal amount of its outstanding Series B Notes.

The Fund will prepay \$11,477,707.01 aggregate principal amount of its outstanding Series C Notes.

The principal amount of the Notes to be prepaid will be allocated among all the Notes outstanding in proportion, as nearly as practicable, to the respective unpaid principal amounts thereof.
