This Amendment No. 1 to Schedule 13G (the "Schedule 13G") is being filed on behalf of Fir Tree Value Master Fund, L.P., a Cayman Islands exempted limited partnership ("Fir Tree Value"), Fir Tree Capital Opportunity Master Fund, L.P., a Cayman Islands exempted limited partnership ("Fir Tree Capital Opportunity") and Fir Tree, Inc., a New York corporation ("Fir Tree"), relating to common stock, par value \$0.0001 (the "Common Stock") of Alternative Asset Management Acquisition Corp., a Delaware corporation (the "Issuer"), purchased by Fir Tree Value and Fir Tree Capital Opportunity. Fir Tree is the investment manager of both Fir Tree Value and Fir Tree Capital Opportunity.

- (a) Fir Tree Value and Fir Tree Capital Opportunity are the beneficial owners of 3,501,734 shares of Common Stock and 707,866 shares of Common Stock, respectively. Fir Tree may be deemed to beneficially own the shares of Common Stock held by Fir Tree Value and Fir Tree Capital Opportunity as a result of being the investment manager of Fir Tree Value and Fir Tree Capital Opportunity.
- (b) Fir Tree Value and Fir Tree Capital Opportunity are the beneficial owners of 6.8% and 1.3%, respectively, of the outstanding shares of Common Stock. Collectively, the Reporting Persons beneficially own 4,209,600 shares of Common Stock which represent 8.1% of the shares of Common Stock outstanding. These percentages are determined by dividing the number of shares of Common Stock beneficially held by 51,750,000, the number of shares of Common Stock issued and outstanding according to the Issuer's Form 10-Q filed with the Securities and Exchange Commission on November 14, 2007.
- (c) Fir Tree Value may direct the vote and disposition of 3,501,734 shares of Common Stock. Fir Tree Capital Opportunity may direct the vote and disposition of 707,866 shares of Common Stock. Fir Tree has been granted investment discretion over the Common Stock held by Fir Tree Value and Capital Opportunity.
