Item 1.01. Entry into a Material Definitive Agreement.

On May 1, 2015, Fastenal Company (the 'Company') entered into a new credit agreement (the 'Credit Agreement') with Wells Fargo Bank, National Association ('Wells Fargo') and the lenders from time to time party thereto (the 'Lenders'), and terminated its existing credit agreement. Wells Fargo serves as Administrative Agent, Swingline Lender, and Issuing Lender under the Credit Agreement. The Credit Agreement provides the Company with a committed \$500,000,000 unsecured revolving credit facility ('Facility'). The Facility includes a committed letter of credit subfacility of \$55,000,000 and an uncommitted swing line loan subfacility of \$25,000,000. The commitments under the Facility will expire on March 1, 2018 and any loans outstanding on such date will mature and be payable on such date. The Company's obligations under the Facility are guaranteed by its material domestic subsidiaries.

A loan under the Facility, other than a swing line loan, shall bear interest at a rate per annum equal to, at the election of the Company, either (i) London Interbank Offered Rate (LIBOR) for an interest period of one month, reset daily, plus 0.95%, or (ii) LIBOR for an interest period of one, two, three, six or twelve months as selected by the Company, reset at the end of the selected interest period, plus 0.95%. Any swing line loan made under the Facility shall bear interest at a rate per annum equal to LIBOR for an interest period of one month, reset daily, plus 0.95%. There is a floor on LIBOR of 0.00%.

In addition, the Company will pay a commitment fee on the average unused portion of the Facility at a rate per annum equal to 0.10%, if the average quarterly utilization of the Facility is 20% or more, or 0.125%, if the average quarterly utilization of the Facility is less than 20%.

A commission fee will be assessed on the amount available to be drawn under each letter of credit issued under the Facility equal to 0.95% per annum. In addition to such commission fee, the Company will be required, subject to certain exceptions, to pay an issuance fee with respect to each letter of credit issued under the Facility equal to 0.075% of the face amount of such letter of credit.

The Credit Agreement requires the Company to maintain its consolidated total leverage ratio as defined in the Credit Agreement as of the end of each fiscal quarter at no more than 1.75 to 1.00, and EBITDA as defined in the Credit Agreement during any consecutive four quarter period at no less than \$400,000,000. These amounts measured as of the end of our most recently completed quarter were 0.19 to 1.00 and \$871,275,000, respectively. The Credit Agreement also contains other customary affirmative and negative covenants, including covenants that restrict the right of the Company and its subsidiaries to merge, to lease, sell or otherwise dispose of assets, to make investments and to grant liens on their assets. In addition, the Credit Agreement, subject to certain limited exceptions, prohibits the Company from incurring additional indebtedness, paying dividends, or engaging in stock buy-backs if there are ongoing defaults or events of default under the Credit Agreement or the Company is not in proforma compliance with its financial covenants.

The Credit Agreement contains customary events of default, the occurrence of which would permit the Lenders to terminate their commitments and accelerate loans (and require cash collateralization of letters of credit) under the Facility, including failure to make payments under the Facility, failure to comply with covenants in the Credit Agreement and other loan documents, cross default to other material indebtedness of the Company or any of its material subsidiaries, failure of the Company or any of its material subsidiaries to pay or discharge material judgments, bankruptcy of the Company or any of its material subsidiaries, and change of control of the Company. The Lenders have performed and may continue to perform commercial banking and financial services for the Company and its subsidiaries for which they have received and will continue to receive customary fees. In addition, Wells Fargo serves and may continue to serve as the Company's transfer agent.

The foregoing description of the Facility is qualified in its entirety by reference to the full text of the Credit Agreement, which is filed as Exhibit 10.1 hereto.

Item 2.03. Creation of a Direct Financial Obligation or an Obligation Under an Off-Balance Sheet Arrangement of a Registrant.

Item 8.01. Other Events

On May 1, 2015, the Company's board of directors authorized purchases by the Company of an additional 4,000,000 shares of its common stock.

As previously disclosed, the Company purchased 2,000,000 shares of its common stock during the first quarter of 2015. These purchases exhausted the then remaining stock purchase authorization. On March 26, 2015, the Company's board of directors established a new authorization for the Company to purchase up to 4,000,000 shares of its common stock. Since March 26, 2015, the Company has purchased 4,000,000 shares of its common stock under this authorization.

With the addition of the May 1, 2015 authorization, the Company currently has authority to purchase up to a total of 4,000,000 shares of its common stock. This authorization does not have an expiration date.
